OFFICE MEMORANDUM

Aizawl, the 5th November, 2013.

Subject: Payment of Dearness Allowances of Revised Pay to the employees of the Government of Mizoram enhanced from existing rate of 80% to 90 % (i.e. 10%) due on 01.07.2013 to be released w.e.f. 01.10.2013.

The undersigned is directed to convey the sanction of the Governor of Mizoram for payment of enhanced Dearness Allowance of **10%** of the **Revised Pay** due on **01.07.2013** to the serving employees of the Government of Mizoram from the existing rate of **80% to 90% (10% increased)** effective from **01.10.2013** on the following conditions:

1. The enhanced portion of **10% of DA** is released to be paid in cash to all employees retiring within 3(three) months counting from **01.11.2013** and those employees governed by the New Pension Scheme as well as those not eligible to subscribe to GPF accounts.
2. The enhanced portion of **10% of DA** is released to be credited **3%** to the GPF Accounts and **7%** in cash to all Group A, B & C employees of the Govt. of Mizoram and **10%** in cash to all Group D employees of the Govt. of Mizoram with effect from **01.10.2013**.
3. The provisions contained in para 2, 3 and 4 of this Department's O.M. of even No. Dt. 26.07.2013 shall continue to be applicable while regulating Dearness Allowances under these orders.
