**STATEMENT OF FINANCE MINISTER ON
SECOND 'VOTE ON ACCOUNT' FOR 2014-2015**

Mr. Speaker Sir,

It is my privilege to inform the House that during the last session in March 2014, I had obtained a 'Vote on Account' for expenditure requirements of the first four months of the current financial year from April to July 2014. That was necessary because the Plan Outlay and the Central support for 2014-2015 have not yet been finalized. The Interim Budget in respect of Annual Plan 2014-2015 was therefore prepared tentatively which would be laid again for seeking the approval of this august House as and when the Plan size for 2014-2015 is determined by the Central Government.

I am compelled to inform the Hon'ble members that due to recent formation of the new Government at the Centre the finalization of Annual Plan of the State is likely to take some more time. I am, therefore, not in a position to present the full Budget and accordingly I am obligated to seek another 'Vote on Account' for four months from August to November 2014.

I, therefore, with your kind approval Sir, and recommendation of His Excellency the Governor of Mizoram, present before this august House the second 'Vote on Account' for expenditure of the Government of Mizoram for August to November 2014 amounting to **Rs.23,77,88,83,000 (Rupees two thousand three hundred seventy seven crore eighty eight lakh eighty three thousand)** only. I hope the House would appreciate the position and give its approval to the 'Vote on Account' as proposed by me.
