Subj:- Timely submission of proposal for Administrative Approval and Expenditure Sanction in respect of CSS

For implementation of the new procedure on release of CSS fund through Single Nodal Agency Accounts (SNA Accounts) and in order to enable transfer of fund to SNA accounts within a period of 21 days of receipt of fund, all concerned departments are hereby informed to do necessary formalities for administrative approval and expenditure sanction even before CSS fund is actually released to make them ready for submission of proposals to Finance Department as soon as fund is released by Govt. of India.

Proposals for fund allocation (if sufficient provision is not available in the budget), administrative approval and expenditure sanction should be submitted to Finance Department within 7 (seven) days of receipt of fund from the Ministry.

In some cases, it is possible that departments come to know release of fund at much later date which will delay timely submission of proposals to Finance Department and which in turn delay crediting of SNA Accounts. To avoid this kind of problem, all CSS-implementing departments should regularly enquire whether fund has been released by concerned ministry of Central Government

Subject :-Passing of bills in respect of CSS funds which are to be transferred to SNA accounts.

Govt. of India issued revised procedures for release of CSS funds as per which funds are to be transferred to SNA accounts within stipulated period. If regular bills are not available at the time of presenting bills to Treasuries in respect of CSS funds which require transfer to SNA accounts, Abstract Contingent bill permission should be obtained specifically from Finance Department (APF) to enable passing of bills by Treasuries.
