#### **OFFICE MEMORANDUM**

In continuation of this Department's Office Memorandum even No. dated 25<sup>th</sup> September, 2020, it is reiterated that the spouse of a Government Servant is excluded from the restriction of facilitating medical treatments irrespective of his/ her income, provided that the spouse does not receive fixed Medical Allowance.

In view of the above, and in order to avoid getting dual benefit of fixed Medical Allowance and medical treatments in respect of the spouse, it is mandated that all Government Servants on claiming of medical treatments bills in respect of their spouses who are retired Government Servants should submit Non-Drawal Certificate of fixed Medical Allowance or a certificate surrendering his/ her fixed Medical Allowance which should be duly countersigned by the concerned Treasury Officer from where the spouse is drawing his/ her monthly pension. A standard format is hereby enclosed for compliance by all concerned.

The Medical Allowance once surrendered can be re-instated after both the spouses get retired from service.
