Subject: Instructions in connection with pending bills and certain cases prior to 01/04/2025 on introduction of MUHCS – reg.

With the implementation of Mizoram Universal Healthcare Scheme, w.e.f 01/04/2025, the following instructions are hereby issued to be followed and complied by all Departments:-

- 1. All pending bills related to Medical Treatment/ Medical Reimbursement of Government servants which have already been approved by Mizoram State Health Care Society (MSHCS) shall be paid by the concerned Department from the Budget provided in the B.E. 2025-26.
- 2. For Patients (Government servants or his/her dependent family members), who were admitted to the empanelled hospitals prior to 1st April, 2025 and who continue to be hospitalised after the implementation of MUHCS, the medical bills shall still be re-imburseable even if the date of discharge is on or after 1st April, 2025 provided that the bills have been checked by Mizoram State Health Care Society.
- 3. For all medical treatments and the expenses which incur on or after 1st April, 2025, the procedures under Mizoram Universal Healthcare Scheme shall be followed.
- 4. Medical Travelling Expenses incurred by Government servants and/or his/her family members under Mizoram Universal Healthcare Scheme shall also be paid from the fund provided under Object Head (06) Medical Treatment until further order.
