OFFICE MEMORANDUM

Subject : Inclusion of Work-charged Employees, Contract Employees and clarification on other groups of employees to 'the Mizoram Universal Healthcare Scheme' – reg.

Whereas this Department's Notification No.D.12015/1/2025-FEA, dated 26th March, 2025 wherein the amount of contribution towards the subscriptions of the Mizoram Universal Healthcare Scheme, 2025 to be deducted from the concerned bills of Government Employees, Provisional Employees and all Pensioners/Family Pensioners under the Government of Mizoram had been notified;

It is hereby clarified that **Work-charged Employees** and **Contract Employees** under the Government of Mizoram who had been allowed to enjoy similar medical reimbursement entitlements to that of the regular State Government Employees shall join the Mizoram Universal Healthcare Scheme as similar to the Regular Employees and they are required to submit family declaration as per the dependency prescribed under Central Services (Medical Attendance) Rules, 1944 in line with the Office Memorandum issued by this office vide No.D.12015/1/2025-FEA dated 26.03.2025 and dt.28.03.2025 which shall be duly countersigned by the concerned Controlling Authorities.

The rates of contribution under these categories of employees shall be equivalent to that of their corresponding Pay Level of the State Government Employees notified in the aforementioned notification. The contribution so deducted shall be credited to Government Accounts under-

Further, it is also clarified that other groups of employees such as CSS employees, Muster Roll employees, staff whose salaries are paid from GIAs, etc., may register themselves as "Contributory Beneficiaries" for current policy period at the rates prescribed under the MUHCS as per their option. Their inclusion under MUHCS may be considered for the subsequent policy year.
