NOTIFICATION

No.D.12015/1/2025-FEA, dated 26th March, 2025: In pursuance of the decision of the Council of Ministers conveyed vide No.J.11011/2/2025-POL dated 20/03/2025 and in the interest of public service and also in line with the notification issued by Health & Family Welfare Department vide **No.D.12016/2/2025-HFW/MUHCS/4 dt.18/03/2025**, the Governor of Mizoram is pleased to notify the amount of contribution towards the subscriptions of the Mizoram Universal Healthcare Scheme, 2025 to be deducted from the concerned bills as specified below:-

1. The contribution of serving Government Employees and Provisional Employees under the Government of Mizoram shall be deducted at the rates as shown in the table below w.e.f salary bill of April 2025:-

| Sl. No | Pay Matrix Level | Rate of deduction per Month |
|--------|-----------------------|-----------------------------|
| 1 | Level 13 & Above | 1,500 |
| 2 | Level 10 -12 | 1,000 |
| 3 | Level 6-9 | 700 |
| 4 | Level 3-5 | 400 |
| 5 | Level 1A-2 | 300 |
| 6 | Level 1 | 300 |
| 7 | Provisional Employees | 200 |

2. All Pensioners/ Family Pensioners under the Government of Mizoram who are willing to contribute the subscription fees shall be categorized based on the amount of their monthly pension into Category-A and Category-B. The Pensioner/ Family Pensioner shall have an option to exercise their willingness to contribute the subscription fees w.e.f April 2025 upto June 2025 at the rates as shown in the table below :-

| Sl.No | Category | Rate of deduction per Month |
|-------|--|-----------------------------|
| 1 | Category-A Monthly basic pension \geq ₹20,000 | 1,000 |
| 2 | Category-B Monthly basic pension $<$ ₹20,000 | 500 |

- 2.1. Pensioners/ Family Pensioners under Category-B shall have an option to subscribe as per Category-A and shall enjoy the admissible packages as per Category-A. However, Category-A cannot subscribe as Category-B.
 - 2.2. The option once exercised will be final and binding for a minimum period of 1 year from the date of exercising the option. Also, unless the option exercised is withdrawn, it shall be treated as option exercised for the succeeding years.
 - 2.3. Those Pensioners/ Family Pensioners who exercise the option after June 2025 shall have to pay the arrears of subscription w.e.f April 2025 with late fees at the rate of ₹100 per month.
 - 2.4. In the cases of pensioners who retire after April 2025, they shall exercise their option immediately from the month of their retirement at the rates as prescribed in the table above without late fees. However, if option is not exercised immediately on retirement, the arrears of subscription along with late fee of ₹100 per month will be applicable from the month of their retirement upto the month of exercising their option.
 - 2.5. Format for exercising options shall be issued by Finance Department.
3. The deduction of the contribution mentioned above shall be remitted to Public Accounts not bearing Interests of the Government Account under appropriate Heads of Accounts to be notified by Finance Department.
 4. **In the case of discontinuance of the MUHCS by the Government of Mizoram, the subscription made will be discontinued and restored in the salary/ monthly pension, as the case may be.**
