The Terms of Reference of the HPSC and procedure to be followed in the screening and approval of the project proposals are laid down below:

- 1. Proposals to be placed before the HSPC shall be in the form of Preliminary Project Report (PPR) which shall contain summary on the administrative and financial aspects of the proposals.
- 2. The HPSC shall scrutinize and prioritize the proposals under UIDF taking into consideration the Normative Allocation of the State under UIDF and within the borrowing limit of the State.
- 3. Upon scrutinizing the proposals, the HSPC may either approve or reject the proposals. Further, the HSPC may also return proposals for any revision (if necessary),

- which shall be re-considered by convening another meeting. The grounds of such rejected/ deferred proposal shall be indicated in the minutes of the meeting.
- 4. Once a project proposal(s) is approved by the HPSC, the same shall then be submitted in DPR form (soft copy and hard copy) along with the minutes of the meeting to Finance Department (EA), the Nodal Department for UIDF, for formal approval and onward submission to the concerned Ministry.
