#### NOTIFICATION

**No. A.12018/8/2003-P&AR(GSW), the 27<sup>th</sup> March, 2011.** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules further to amend the Mizoram Finance and Accounts Service Rules, 2008 (hereinafter referred to as the Principal Rules), namely :-

1. *Short Title and Commencement*
  - (1) These Rules may be called the Mizoram Finance and Accounts Service (First Amendment) Rules, 2011.
  - (2) They shall come into force from the date of their publication in the Mizoram Gazette.
2. *Amendment of Rule 16*

In sub-rule (1) of rule 16 of the Principal Rules, the following shall be substituted, namely :-  
“(1) Every person appointed to the Junior Grade of the service by direct recruitment shall be on probation for a period of 2(two) years”.
3. *Amendment of Rule 18*

In rule 18 of the Principal Rules, the following shall be substituted, namely :-  
“For promotion to higher grade, every member in the Junior Grade of the service shall appear and pass such departmental examination as may be prescribed in the Rules and conducted by the Commission”.
4. *Amendment of Rule 22*

In sub-rule (1) of rule 22 of the Principal rules, the following shall be substituted, namely :-  
“(1) The increment due to a probationer in the time scale of pay shall accrue on successful completion of the probation and passing of departmental examination as may be prescribed in the Rules and conducted by the Commission”.
5. *Amendment of Rule 23*

In sub-rule (2) of rule 23 of the Principal Rules, the following shall be substituted, namely :-  
“(2) A member of the Junior Grade of the service with a minimum period of 5 years regular service in the grade and has passed departmental examination shall be eligible for promotion to the Senior Grade”.

6. *Amendment of the Schedule* In the Principal Rules, the authorised permanent strength of the service shall be substituted by the following, namely :-
