Payment of Dearness Allowances of Revised Pay to the employees of the Government of Mizoram enhanced from existing rate of 58% to 65% due on 01.01.2012 to be released w.e.f. 01.10.2012.

All Heads of Administrative Department

The undersigned is directed to convey the sanction of the Governor of Mizoram for payment of enhanced Dearness Allowance payable to the serving employees of the Government of Mizoram from the existing rate of **58% to 65%** (7% increased) with effect from 01.10.2012 on the following conditions:

- 1. The enhanced portion of 7 % of DA is released to be paid in cash to all Group D employees of the Government of Mizoram and those retiring within 3(three) months with effect from 01.10.2012 and those employees governed by the new pension scheme as well as those not eligible to GPF accounts.
- 2. The enhanced portion of 7 % of DA is released to be credited to the GPF Accounts of all Groups A, B & C employees of the Government of Mizoram with effect from 01.10.2012.
- The provisions contained in para 2, 3 and 4 of the Government of India Ministry of Finance O.M. No. 1 (13)/97-E-11(B) of 3.10.1997 shall continue to be applicable while regulating Dearness Allowances under these orders.
