OFFICE MEMORANDUM

Aizawl, the 17th August, 2010.

Consequent upon the implementation of the Mizoram (Revision of Pay) Rules, 2010 as notified by Finance Department under No.G.12017/2/2008-FIN(PRU) dt. 6.8.2010 and grant of revised rates of different allowances vide Finance Department Notification No.A.26019/1/09-FIN(PRU) dt. 6.8.2010, the Government has decided that Dearness Allowance shall be given to the employees of the Government of Mizoram on the basis of Revised Pay structure w.e.f. 1.1.2009 at the rates appended in Annex-A of this Office Memorandum. However, a portion of Dearness Allowance in respect of the employees of the State Government shall continue to be impounded into the GPF accounts of the employees in the following manner:-

1. The rate of amounts being impounded into the GPF accounts of all employees prior to 1.8.2010 shall stop forthwith (except the arrears of pay and allowances in the revised pay structure for the period from 1.1.2009 – 31.7.2010).
2. For all employees in Group A, B and C 22% out of the 35% Dearness Allowance (sanctioned w.e.f 1.1.2010) shall be impounded into the GPF accounts of the employees concerned.
3. For Group D employees 12% out of 35% Dearness Allowance (sanctioned w.e.f. 1.1.2010) shall be impounded into the GPF accounts of the employees concerned.
4. Those employees retiring within 3 month of issue of this Office Memorandum and employees who are not eligible to subscribe to GPF accounts may draw Dearness Allowance in cash.

All Administrative Departments and Heads of offices should ensure that all employees under their Departments/Offices revise their normal subscription towards GPF accounts at the rate not less than the prescribed minimum rate of 6% of his / her emoluments (Pay on the pay


band, Grade pay, NPA, Stagnation Increment and Personal Pay classed as pay by the President of India) on and from 1.8.2010 onwards. The same method shall also apply to Government Servants who opted to retain their pre revised scale of pay.

Sanction of enhanced Dearness Allowance w.e.f. 1.1.2009 on the basis of the Mizoram (Revision of Pay) Rules, 2010.

Effective Date	Date of Dearness Allowance

The employees who opted to retain the pre-revised pay scales shall continue to draw Dearness Allowance in the pre revised rates.

1. The rate of amount being impounded into the GPF accounts of all employees prior to 1.8.2010 shall stop forthwith except the arrears of pay and allowances in the revised pay structure for the period from 1.1.2009 - 31.7.2010.
2. For all employees in Group A, B and C 22% out of the 35% Dearness Allowance (sanctioned w.e.f. 1.1.2010) shall be impounded into the GPF accounts of the employees concerned.
3. For Group D employees 12% out of 35% Dearness Allowance (sanctioned w.e.f. 1.1.2010) shall be impounded into the GPF accounts of the employees concerned.
4. Those employees retiring within 3 months of issue of this Office Memorandum and employees who are not eligible to subscribe to GPF accounts may draw Dearness Allowance in cash.

All Administrative Departments and Heads of offices should ensure that all employees under their Departments/Offices revise their contribution towards GPF accounts at the rate not less than the prescribed rate of 6% of his/her emoluments (Pay on the pay).
