Payment of Dearness Allowances of Revised Pay to the employees of the Government of Mizoram enhanced from existing rate of 90% to 100 % (i.e. 10%) due on 01.01.2014 to be released w.e.f. 1.7.2014.

The undersigned is directed to convey the sanction of the Governor of Mizoram for payment of enhanced Dearness Allowance of 10% of the Revised Pay due on 01.01.2014 to the serving employees of the Government of Mizoram from the existing rate of 90% to 100% (10% increased) effective from 1.7.2014 on the following conditions:

- 1. The enhanced portion of 10% of DA is released to be paid in cash to all employees retiring within 3 (three) months counting from 01.07.2014 and those employees governed by the New Pension Scheme as well as those not eligible to subscribe to GPF accounts.
- 2. The enhance portion of 10% D.A is also released to be paid in cash to all those employees who are paying Income Tax as per the Income Tax Act, 1961. The concerned D.D.O. shall write the Permanent Account Number (PAN) of those employees in the Pay Bill with a certificate showing that the incumbent is an Income tax prayer while submitting the Pay Bill to the Treasury for payment.
- 3. 5% of the enhanced portion of 10% of DA is to be credited to the GPF Accounts and the rest 5% is to be paid in cash to all Group A, B, C & D employees of the Govt. of Mizoram with effect from 1.7.2014.
- 4. The provisions contained in para 2, 3 and 4 of this Department's O.M. of even No. Dt. 26.07.2013 shall continue to be applicable while regulating Dearness Allowances under these orders.
