OFFICE MEMORANDUM

Aizawl, the 23rd April, 2010.

Subject: Payment of Dearness Allowances to the employees of the Government of Mizoram enhanced from the existing rate of 73% to 87% w.e.f. 1.1.2010.

The undersigned is directed to convey the sanction of the Governor of Mizoram to payment of Dearness Allowance to the employees of the Government of Mizoram enhanced from the existing rate of 73% to 87% with effect from 1.1.2010 on the following conditions.

1. The enhanced portion of 14 % of DA is released in cash to Group 'D' Employees w.e.f. 1.1.2010.
2. For all Group 'C', 'B' and 'A' the enhanced DA rate of 14% shall be impounded to GPF/Saving Certificate with effect from 1.1.2010 to 31.3.2010 and will be paid in cash with effect from 1.4.2010.
3. For employees not eligible to or not yet having GPF Account, the enhanced D.A. for the period w.e.f. 1.1.2010 to 31.3.2010 may be invested in National Saving Scheme of appropriate Term Deposits etc.
4. For employees paid from Grants-in-Aid, the enhanced Dearness Allowances of 14% shall be invested in their respective CPF/EPF or Small Savings Schemes for the period w.e.f. 1.1.2010 to 31.3.2010. The DA shall be paid in cash w.e.f. 1.4.2010.
5. For employees due to retire on superannuation within 3 (three) months from the date of issue of this Office Memorandum, the enhance D.A. shall be paid in cash with effect from 1.1.2010.
6. Contract employees of any grade, if they are entitled to Dearness Allowance, shall be allowed to draw the arrears in cash w.e.f. 1.1.2010.
7. The provisions contained in para 3, 4 and 5 of the Government of India Ministry of Finance O.M. No. 1 (13)/97-E-11(B) of 3.10.1977 shall continue to be applicable while regulating Dearness Allowances under these orders. However, with effect from 1.1.2007 Dearness Allowances will be computed on the basis of Basic Pay, Dearness Pay, Stagnation Increment and NPA. Provisions contained in para 3 of the Ministry of Finance's O.M. No. 1 (13)-E-11(B) dated 3.10.1997 had already been amended to this extend with effect from 1.4.2004.
