## OFFICE MEMORANDUM

Dated Aizawl, the 11th June, 2019.

Subject: Payment of Dearness Allowance to the employees of the Government of Mizoram.

The undersigned is directed to convey the sanction of the Governor of Mizoram to payment of enhanced Dearness Allowance to the regular employees of the Government of Mizoram @ 3% w.ef. 01.01.2019 (enhanced by 3% from the existing rate of 9% to 12%), with monetary benefit from 01.01.2019 on the following conditions:-

- The enhanced Dearness Allowance is released to be paid in cash from salary of June, 2019, but arrears between 01.01.2019 and 31.05.2019 are to be impounded into GPF accounts, except in respect of NPS subscribers who do not have GPF accounts and of those employees who are to retire within three months.
- 2. The term "Basic Pay" in the revised pay structure means the pay drawn in the prescribed Pay Matrix Table but does not include any other type of pay like special pay, etc. For the purpose of calculation of dearness allowances, non-practising allowances, where applicable shall be taken into account.
- 3. The provisions contained in para 3 and 4 of this Department's O.M of even No. Dt.26.07.2013 shall continue to be applicable while regulating Dearness Allowance under this order.
