The undersigned is directed to convey the sanction of the Governor of Mizoram for payment of enhanced Dearness Allowance of 13% (i.e. 7%+6% due on 01.7.2014 and 01.01.2015 respectively) to the serving employees of the Government of Mizoram from the existing rate of 100% to 113% (13% increased) effective from 01.04.2015 on the following conditions:

> 1. The enhanced portion of 13% of DA is released to be paid in cash to all employees retiring within 3 (three) months counting from 01.04.2015 and those employees governed by the New Pension Scheme as well as those not eligible to subscribe to GPF accounts.

The enhance portion of 13% D.A is also released to be paid in cash to all those employees who are paying Income Tax as per the Income Tax Act, 1961. The Government of Mizor concerned D.D.O. shall write the Permanent Account Number (PAN) of those epartment (PRU) employees in the Pay Bill with a certificate showing that the incumbent is an Income tax payer while submitting the Pay Bill to the Treasury for payment.

- 3. Out of 13% of the enhanced DA, 7% of DA is to be fully credited to the GPF Accounts and the rest 6% is to be paid in cash to all Group A, B, C & D employees of the Govt. of Mizoram with effect from 01.04.2015.
- 4. The provisions contained in para 2, 3 and 4 of this Department's O.M. of even No. Dt. 26.07.2013 shall continue to be applicable while regulating Dearness Allowances under these orders.
