Subject: Payment of Dearness Allowances of Revised Pay to the employees of the Government of Mizoram enhanced from the existing rate of 113% to 119% to be released w.e.f. 01.04.2016.

The undersigned is directed to convey the sanction of the Governor of Mizoram to payment of enhanced Dearness Allowance of Revised Pay to the serving employees of the Government of Mizoram from the existing rate of 113% to 119% (6% increased) effective from 01.04.2016 on the following conditions:-

- 1. The enhanced portion of 6% of Dearness Allowance is released to be paid in cash to all employees governed by the New Pension Scheme as well as those not eligible to subscribe to GPF accounts.
- 2. The enhanced portion of 6% Dearness Allowance is also released to be paid in cash to all those employees who are paying Income Tax as per the Income Tax Act, 1961. The concerned D.D.O shall write the Permanent Account Number (PAN) on those employees in the Pay Bill with a certificate showing that the incumbent is an Income tax payer while submitting the Pay Bill to the Treasury for payment.
- 3. The enhanced Dearness Allowance, 6% of DA is to be fully paid in cash to all Group A, B, C & D employees of the Government of Mizoram with effect from 01.04.2016.
- 4. The provisions contained in para 2,3 and 4 of this Department's O.M of even No. Dt.26.07.2013 shall continue to be applicable while regulating Dearness Allowance under these orders.
