No G.11021/13/93-FCC: In exercise of the powers conferred by Section 8 of the Mizoram Finance Commission Act, 2010 (Act No.17 of 2010), the Governor of Mizoram is pleased to make the following rules to amend the Mizoram Finance Commission (Salaries and Allowances) Rules 2010 (hereinafter referred to as the Principal Rules) as follows, namely:-

- 1. Short title and commencement:-
- (1) These rules may be called the Mizoram Finance Commission (Salaries and Allowances) (Amendment) Rules, 2012.
- (2) They shall come into force from the date of their publication in the Official Gazette
- 2. Amendment of rule 2:-

For sub-rule (2) of rule 2 of the principal rules, the following sub-rules shall be substituted, namely.-

- "(2) (a) If the Chairman is not given a status of a Cabinet Minister and if he is a retired Government servant, he shall be entitled to draw the pay and all allowances including travelling allowance, daily allowance, perquisite and status as admissible to him in the post he occupied immediately before his retirement from Government less the pension, including the pensionary equivalent of any other form of retirement benefit.
- "(2) (b) If the Chairman is not given a status of a Cabinet Minister, and if he is not a retired Government servant, he shall be entitled to draw pay and all allowances including travelling allowance, daily allowance, perquisite and status as admissible to the rank of Principal Secretary to the Government of Mizoram".

- 3. Amendment of
- For sub-rule (2) of rule 3 of the principal rule 3:rules, the following sub-rules shall be substituted, namely-
- "(2) (a) If the Member or Member Secretary is not given a status of a Minister of State, and if he is a retired Government servant, he shall be entitled to draw the pay and all allowances including travelling allowance, daily allowance, perquisite and status as admissible to him in the post he occupied immediately before his retirement from Government less the pension, including the pensionary equivalent of any other form of retirement benefit.
- "(b) If the Member or Member Secretary is not given a status of a Minister of State, and if he is not a retired Government servant, he shall be entitled to draw pay and all allowances including travelling allowance, daily allowance, perquisite and status as admissible to the rank of Secretary to the Government of Mizoram".
