OFFICE MEMORANDUM

In view of a slight improvement in the financial conditions of the state, the Governor of Mizoram is pleased to curtail the period of deferment of salaries for government employees notified vide OM No.G.17014/4/2019-FEA dt.11th June 2020 as follows:

1. Salary deferment of government servants for a period of three months i.e. June to August notified vide OM No.G.17014/4/2019-FEA dt. 11.06.2020 shall be effective till the month of July 2020.
2. All government employees shall be paid their salary in full from the month of August.
3. Government employee having General Provident Fund (GPF) account may give an option to the DDO concerned to either impound the reimbursement of deferred salary to the GPF account or receive in cash. Failure to exercise the option will result in automatic credit of the amount in the GPF account.
4. For government employee who opted for cash payment, repayment of the salary so deferred in respect of June 2020 shall be done in the month of August 2020 along with payment of salary for the month of August. Accordingly, repayment of the salary so deferred in respect of July 2020 shall be done in the month of September 2020 along with payment of salary for the month of September.
5. For government employee who opted for credit to GPF account, repayment of the deferred salary for the months of June and July shall be done in one instalment along with payment of salary of August.
6. Government employee not having GPF account shall be repaid as per Para No. 4.
