OFFICE MEMORANDUM

Subject: Economy Measures on Publishing Annual Calendar and Foreign Travel.

Finance Department, Government of Mizoram has been issuing instructions from time to time on expenditure management and on the need for economy and rationalization of Government expenditure. These measures are intended at promoting fiscal discipline without restricting the operational efficiency of the Government.

With a view to further stress the importance of economy, the following instructions are issued for strict compliance by all concerned with immediate effect and until further orders:

- 1. Publishing of Annual Calendar:** As publishing of Annual Calendar is being done by Information & Public Relations Department, no other department should indulge in publication of such calendar especially when the expenditure is to be paid from State's budget. Even if departments are required to give publicity regarding the schemes implemented through funding from CSS or other Central Scheme, and if considered absolutely necessary prior permission of Hon'ble Chief Minister is to be obtained for publishing Calendar.
- 2. Foreign Travel:** Travelling abroad at the cost of the State's Exchequer is totally banned. For extreme necessity and purely in public interest such travelling may be done with prior permission of Hon'ble Chief Minister. This ban, however, shall not include scheme related travels which are sponsored by the scheme or other funding agency.

Commissioner/Secretaries who are the Administrative Head of Departments being the Chief Accounting Authorities as per Rule 64 of GFR shall be fully charged with the responsibility of ensuring compliance of these directives. Suitable instructions on the above lines may be issued by them in respect of attached, subordinate offices, autonomous or statutory organizations/entities or field establishments under their administrative control.


