OFFICE MEMORANDUM

**Subject: Clarification on dependency of family members.**

It has come to the notice of the undersigned that there are certain queries relating to dependency of family members for medical claims which was recently issued vide OM even No. dated 27/07/2020. All Departments under the Government of Mizoram are requested to observe the following clarifications:-

1. **Exclusion of Spouse from restriction :** As per Government of India's decision vide Note 1 under Section IV-I(1) of CS(MA) Rules, 1944, a Government servant's husband or wife is allowed for facilitating medical treatments irrespective of his/her income, provided that the spouse does not receive fixed Medical Allowances.
2. **Submission of Declaration:** Fresh declaration on dependency of family members as per prescribed format will be submitted by the Government servants along with each medical claim.
3. The Office Memorandum under reference shall not apply to the dependent patients who were hospitalised prior to the date of issue.
