NOTIFICATION

Dated Aizawl, the 6th September, 2022.

In pursuance of the decision of the Council of Ministers in its meeting held on 30th August, 2022, the following allowances are hereby granted to employees under Samagra Shiksha:-

1. Dearness Allowance @ 15% of remuneration for all Samagra Shiksha employees.
2. Medical Allowance @ Rs.1,000/-p.m for all Samagra Shiksha employees.
3. Additional Allowance @ 5% to teaching staffs who have completed 8 years of service but less than 16 years and to non-teaching staffs who have completed 10 years but less than 20 years.
4. Additional Allowance @ 10% to teaching staffs who have completed 16 years of service and to non-teaching staffs who have completed 20 years. This 10% shall subsume 5% which have been received after 8 years or 10 years of service, as the case may be.

Minimum remuneration including these allowances is fixed at Rs 12,000/- p.m.

Further, the post of Substitute Teacher under Samagra Shiksha is re-designated as Teacher with remuneration of Rs 20,000/- p.m and allowances as admissible as other teachers which will become at par with remuneration of corresponding Teacher.
