1. The Terms of Reference of the MRMC shall be as follows.
  - a) The MRMC shall function as an advisory body to the Government on all matters relating to Mobilization of Resources on states own Tax and Non Tax Revenue.
  - b) The MRMC shall make an assessment of Government expenditure and review the selected items so as to reduce the expenditure of the State Government as an economy measure.
  - c) MRMC shall also study and suggest the possibilities of converging schemes, projects, programmes etc. of all kinds funded by the Central Government and other sources with those of the ones funded and implemented by the State Government.
  - d) MRMC shall also coordinate, review and monitor recoveries of all kinds of loans given by the State Government in the past.
  - e) The MRMC shall also take up any other functions which may be assigned to it by the State Government from time to time.

2. The Chairman of MRMC may associate any pensioner or officer working under the Government of Mizoram as co-opted members as and when required.
3. The Finance Department, Government of Mizoram shall extend secretarial support to the MRMC.
4. The Chairman, Vice-Chairman and all the Members shall be entitled to sitting allowance at the rate of ₹ 1000/- (*Rupees One Thousand*) only per sitting. In addition, the members at Sl no.(4) and no.(5) above shall be entitled to transport allowance of ₹ 500/- (*Rupees Five Hundred*) only per sitting.
5. The entire expenditure required for the MRMC shall be borne by the Planning and Programme Implementation Department (RDB), Government of Mizoram.
