In pursuance of the decision of the Council of Ministers and as per the Explanatory Memorandum as to the action taken on the recommendation made by the Second Mizoram Finance Commission which was laid before the State Legislature on 23<sup>rd</sup> August, 2023; the Governor of Mizoram is pleased to issue Notification on implementation of accepted recommendations of the Second Mizoram Finance Commission as below:-

(i) Vertical devolution of taxes: 42 percent of the net proceeds of the State's own tax revenue shall be devolved to the Local bodies as indicated in the Table below:-

(iv) Devolution to Local Councils from share of Municipalities: The Municipalities shall devolve 20% of the tax devolution from the State Government to the Local Councils. The inter se shares of local councils out of 20% of the State tax devolution for each Local Council shall be as per Para-9.53, Annexure 9.36 & 9.37 of the Report.

The recommendations on devolution of tax, deficit grants and horizontal devolution shall be implemented from the year 2024-25.

- (v) Book of Accounts and Asset Register for Village Councils: Maintenance and submission of accounts and Asset Register to the District Local Administration Officer at the end of every financial year shall be the pre-requisite condition for release of grants recommended by the State Finance Commission. (Para-6.60 & 6.61)
- (vi) Other Recommendations: Other recommendations will be considered in due course since it is considered necessary to first have consultations with various stakeholders.

  Notes:
  - 1. If SOTR in the revised estimates is less than the projection, it will not be feasible/realistic to devolve absolute shares recommended by the Commission. In such circumstance, percentages corresponding to absolute figures shall be used for calculation of absolute shares for the 1<sup>st</sup> level horizontal devolution. Subsequent horizontal devolution shall be recalculated accordingly.
  - 2. The approach taken by the Commission is to make recommendations to fullymeet expenditure needs of local bodies and ADCs. If SOTR in Revised Estimate is equal to or more than the projection of the Commission, the recommended amounts will be sufficient to fully meet expenditure needs of local bodies and ADCs and hence to devolve more than assessed expenditure needs will not be necessary. Meantime, Deficit Grants are fixed grants as in the case of Central Finance Commission recommendations and is independent of tax devolution.
