In the interest of public service and pursuant to instructions issued by Election Commission of India vide No.464/INST/EPS/2023/Honorarium Dt. 06.06.2023, and in consultation with Chief Electoral Officer, Mizoram, the Governor of Mizoram is pleased to fix the **rates of honorarium to all election staff deployed for election duties** as applicable to them respectively as under :-

RATE OF HONORARIUM		
Sl. No.	Category of Beneficiaries	Rates
1	a) DEOs/ROs/AROs/Officers and staff working in the office of Chief Electoral Officer actually deployed for election duties for a period of 30 days or longer. b) Officers and staff working in the Office of District Election Officers actually deployed for election duties for a period of 30 days or longer. c) Any other officials who are duly appointed/ deployed by the Chief Electoral Officer or District Election Officers for the purpose of election duties for a period of 30 days or longer. <i>Note : No Honorarium shall be paid to the Officers and staff who are deployed on shift duty and who did not perform election related duties less than 30 days</i>	1(one) month's Basic Pay (Subject to change as per Election Commission of India's instruction)
2	Gazetted Officers of CAPF (Commandant, Deputy Commandant, Assistant Commandant, Medical Officer and other equivalent ranks)	15 days or less- ₹2500/- more than 15 days - @ ₹1,250/- per week
3	Subordinate Officers of CAPF (Inspector, Sub-Inspector, Asstt. Sub-Inspector and other equivalent ranks)	15 days or less- ₹ 2,500/- more than 15 days - @ ₹1,000 per week
4	Other Ranks of CAPF (Head constable, Constable and equivalent ranks)	15 days or less- ₹1,500/- more than 15 days - @ ₹750 per week
5	Assistant Expenditure Observer/Sector Officer/Sector Police Officer	₹7,500/- for his full-time election duty or on pro rata basis proportional to the duration of duty.

The above rates will be applicable only for General Election to Parliament and State Assembly and not to Bye Election.
