## **NOTIFICATION**

In pursuance of 'The High Court and Supreme Court Judges (Salaries and Conditions of Service) Amendment Act, 2018' (Act No 10 of 2018) and in exercise of the power conferred under Section 16(5) of the Right to Information Act, 2005, the Governor of Mizoram is pleased to order Revision of Pay and Allowances of existing incumbent of the State Chief Information Commissioner, Mizoram and State Information Commissioner, Mizoram appointed before the commencement of the RTI (Terms of Office, Salaries, Allowances and other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioner in the Central Information Commission, State Chief Information Commissioner and State Information Commissioner in the State Information Commission) Rules, 2019, that is 24th October, 2019 as under:-

- 1. State Chief Information Commissioner, Mizoram:
- (i) Pay: Rs 2,50,000/- per month (Consolidated) to be reduced by the amount of monthly pension drawn per month w.e.f. 1.1.2016.
  - (ii) <u>Dearness Allowances</u>: As admissible to the Judge of the Supreme Court from time to time.
  - (iii) House Rent Allowance: If the State Chief Information Commissioner, Mizoram does not avail himself of the use of an official residence, he may be paid every month an allowance equivalent to an amount of 24% of the salary which shall be increased at the rate of-
  - (a) twenty seven per centum, when Dearness Allowance crosses twenty five per centum, and
  - (b) thirty per centum, when Dearness Allowance crosses fifty per centum. House Rent Allowance shall be revised w.e.f. 1.7.2017.
  - (iv) Sumptuary Allowance: Rs 34,000/- p.m. w.e.f. 22.9.2017.
  - (v) Special Compensatory Allowance: Rs 3,400/- p.m. w.e.f. 1.7.2017.
- 2. The State Information Commissioner, Mizoram:
  - (i) Pay: Rs 2,25,000/- p.m. (fixed) to be reduced by the amount of monthly pension w.e.f. 1.1.2016.

- (ii) <u>Dearness Allowance</u>: As admissible to the Chief Secretary of Mizoram from time to time.
- (iii) House rent Allowance: As admissible to the Chief Secretary of Mizoram from time to time w.e.f. 1.7.2017.
- (iv) Special Compensatory Allowance: Rs 3,400/- p.m w.e.f. 1.7.2017.

The order regarding pension, other facilities and perquisites admissible to the State Chief Information Commissioner and State Information Commissioner, Mizoram shall be issued in due course of time.

All arrears of pay and allowances w.e.f. 1.1.2016 shall be paid in cash subject to availability of fund provision under the appropriate head.
