

**OFFICE MEMORANDUM**

***Aizawl, 25<sup>th</sup> August, 2016***

Instances have come to notice of the Government that some Departments condone half of the services rendered by Government servant in Muster Roll capacity by applying GIO (2) under Rule 14 of CCS Pension Rules, 1972.

The provision of GIO (2) under Rule 14 of CCS (Pension) Rules, 1972 clearly states that half the service paid from contingencies will be allowed to count towards pension at the time of absorption in regular employment subject to certain conditions.

As Muster Roll employees under Government of Mizoram are paid under wages head but not from contingencies and since New Pension Scheme, 2010 also came into force with effect from 1.9.2010, it is hereby informed that all Administrative Departments and Head of Departments that condoning of half of services rendered by Muster Roll employees under the CCS (Pension) Rules, 1972 is not permissible.

All Administrative Departments & All Heads of Departments are therefore informed to strictly comply with these instructions.
