OFFICE MEMORANDUM

Dated Aizawl, the 5<sup>th</sup> May, 2006.

**Subject :** Opening of Bank Account.

On the introduction of Banking Cash Transaction Tax (BCTT) by the Government of India from August, 2005 the Government of Mizoram in the Finance Department issued Office Memorandum No.G.25016/2/93-F.APF dated 13<sup>th</sup> March, 2006 encouraging opening of Bank Account by Government Departments and Offices.

However, the Government of Mizoram has made a separate provision of fund for meeting the expenses on account of cash withdrawals from the Bank by Government Departments and Offices. All such Payments shall be made by the Government through Accountant General for settlement with the Bank. And, individual departments or offices need not pay the tax (BCTT) against their cash withdrawals from the Bank excepting those payments by cheque or Bill endorsement to private / individual parties.

Now, therefore, the aforementioned Office Memorandum is hereby repealed with immediate effect. All Departments / Offices are requested to note that opening of Bank Accounts in the name of the Departments / Offices should be voided to the best possible extent and prior permission of Finance Department should invariably be obtained in case of absolute necessity to open Bank Accounts for specific projects, schemes and agencies for which there is special financial regulations to do so.

Receipt of this Office Memorandum may please be acknowledged and copies of the same maybe re-circulated to all subordinate offices and establishment for strict compliance.
